# **Bethel Church Elder Policy**

#### **Qualifications**

Before accepting the opportunity to serve as an Elder, the candidate should read the Biblical qualifications for elders as found in I Timothy 3:2, Titus 1:6-9 & I Peter 5:1-4. Below is a partial summary of qualifications found in the scriptures.

Before serving as an Elder, the Church asks the candidate to consider their motives for wanting to serve and their willingness to become a servant of God's Church.

- 1) Committed to God's word as authoritative
- 2) Committed to serving God's church with a humble willing heart.
- 3) Not motivated by lust for money, power, or personal reward
- 4) Serving as a shepherd to lead his/her flock, not driving the flock
- 5) Able to defend the faith
- 6) A good representative of Christ among non-Christians
- 7) Sensible, calm and collected with spirit
- 8) Unimpeachable integrity
- Calls others to wholeness through the teaching or sharing of God's word
- 10) A good leader in his/her own family
- 11) Hospitable
- 12) Not overly fond of wine or drunken

#### Responsibilities

- 1) Current Elders will give the incoming Elder training during the first 30 days.
- 2) Elders are to be prayerful in asking for God's direction and will for Bethel.
- 3) Each Elder is responsible for overseeing the congregation, as a shepherd would oversee his sheep. An Elder should be available for physical, emotional and spiritual support of all members of the congregation. Each Elder is assigned an alphabetical listing of active church members to shepherd.
- 4) The Elders are responsible for the spiritual growth of Bethel. Each fall the Elders should review Bethel's spiritual growth progress and use this evaluation as a tool for establishing the next year's goals.
- 5) Elders are to assist the Pastor in visitation, and fill the pastor's role when he is unavailable. Elders are to meet with the pastor monthly to encourage and direct the pastor in meeting the needs of Bethel's congregation.
- 6) Elders are to serve as supervisors of the Pastor to ensure the Pastor is consistently fulfilling his duties.
- 7) The Senior Elder is responsible for communion services.
- 8) The retired elder from the previous year is responsible for finding an elder candidate for the January congregational meeting. If the elder candidate is rejected at the annual congregational meeting, nominations may be made from the floor.

# Mission News Missionary Nathan Graves Update

Dear praying friends and family,

Before our furlough began in 2008, many of you followed my e-mails describing our chronological study with three young men, Gerti, Eri and Shkelzen. Two of those young men, Gerti and Eri are brothers who were from a Muslim family. They came to learn English and ended up trusting Christ as their Savior. While we were away, a fellow worker and his teenage son took over the teaching and discipleship while we were in the States. It was during this time that Gerti and Eri lead their father to Christ. Though he was a Muslim, he saw how their lives and his wife's life had been changed by the gospel. He asked them many questions and finally told them he was ready to make his decision for Christ.

Two weeks ago these young men sought me out to see if we could begin the Bible studies again. They were hoping that the teaching would go deeper than the Creation to Christ study they had been doing. On Saturday, they showed up at our house unannounced to begin studying the Bible. I wasn't there so Lorraine directed them over to my office where we began a study of Ephesians.

I began with an introduction to the life of Paul. Their eyes lit up when they read the Acts account of how Paul persecuted the church and then his conversion on the Road to Damascus. Paul had been a terrorist, who went into the homes of Christians, dragging them out and putting them in prison. But in a moment of time, he came face to face with the Truth, and his life was changed forever. We came to chapter 9 verse 20: "and immediately he began to proclaim Jesus in the synagogues, saying 'He is the Son of God." One day Paul was arresting Christians for proclaiming Him to be the Son of God. A few short days later Paul is preaching this same Jesus as the Son of God.

After reading this passage, Gerti in obvious distress, put his head down. He said, "Do you remember the day Eri and I were with our friends on the road and we saw you and your family?" I told him I remembered. He went on, "After we left, our friends began asking us who you were and how we knew you. They were all new friends and I was afraid to tell them that you were teaching us the Bible and that we are Christians now. Please forgive me for being ashamed of you and the Lord." I told Gerti that I forgave him but that he needed to tell the Lord the same. He bowed his head and said the most beautiful prayer: "Lord, forgive me for denying you before my friends. I am sorry that I was ashamed of you. Thank you for saving me and for all you have done for me. Help me to never be ashamed of you again." Then Eri wanted to pray the same thing.

After they prayed, the weight of their words hit me. These young men had

been Muslims, and were in a known Muslim family. Now they were making a public decision to proclaim Jesus as the Son of God. It meant the real possibility of being persecuted and rejected by their friends. But there, with hearts full of the Spirit, they made a decision to make their faith public, just as Paul had done.

Think about this for a moment. What price do you and I pay for being followers of Jesus? Whatever the price has been for you and me, the price for Gerti and Eri is so much higher. Reading the words of scripture, they came face to face with their new faith as never before. For them it immediately became a matter of life and death. They weighed the pros and the cons and decided it is more important to be identified with Christ as the Son of God than to be liked and accepted by their friends and the religious community they had grown up under.

Please pray for these two soldiers of the cross. Tonight I will be meeting with their father to see when I can begin meeting him for discipleship. Please pray, too, for us to find a place to rent for our services.

Before our meal, we all dressed like a pilgrim or an Indian and had our pictures taken. We also took group pictures and we will display them on our picture board soon. I want to thank Miss Ruth and all the great moms for helping me with this big project.

I will say all the children were perfect. I was so proud of them! This is the first year I combined both classes together and I must say I had my doubts putting that many children together. The mothers couldn't believe how good they were.

I read many books to the children about how the Pilgrims left England to come to America so they could worship God. I told them about the baby named Oceanus, who was born on the Mayflower. I recently questioned the children if they could remember the name of the baby and one little girl said, "Yes, his name was baby Jesus." I told her that story would be coming in December. I still think she is convinced Baby Jesus was born on the Mayflower.

I told them how Squanto taught the Pilgrims how to grow corn, using a dead fish for fertilizer. One little boy informed me there was an easier way. He said, "You just pick up the phone and call the fertilizer man." I'm certain Squanto did not have a cell phone handy!
